Section 4 – Hazards Identification

Eye: Causes eye irritation.
Skin: Causes skin irritation. Harmful if absorbed through the skin.

Ingestion: May cause irritation of the digestive tract. Toxic if swallowed.

Inhalation: Harmful if inhaled. Causes respiratory tract irritation.

Section 5 – First Aid Measures

Ingestion: Get medical aid immediately. Wash mouth out with water.

Inhalation: Remove from exposure and move to fresh air immediately. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical aid.

Section 6 – Stability and Reactivity

Chemical Stability: Stable under normal temperatures and pressures.

Materials to avoid: Strong oxidizing agents, strong bases.

Conditions to Avoid: Incompatible materials.

Hazardous Decomposition Products: Hydrogen chloride, nitrogen oxides, carbon monoxide, carbon dioxide, hydrogen fluoride gas.

Hazardous Polymerization: Will not occur.

Section 7 – Handling and Storage

Handling: Avoid breathing dust, vapor, mist, or gas. Keep container tightly closed. Avoid contact with skin and eyes. Wash thoroughly after handling. Mechanical exhaust required.

Storage: Store in a cool, dry place. Store in a tightly closed container. Keep away from sources of ignition
