Section 4 - Hazards Identification

Eye: Causes eye irritation.

Storage: Store in cool place, Keep container tightly closed in a dry and well-ventilated place. Ensure adequate ventilation during use. Use only in a chemical fume hood. Avoid sources of ignition.
