Section 4 – Hazards Identification



Eye:Causes eye irritation.Skin:Causes skin irritation. Harmful if absorbed through the skin.Ingestion:May cause irritation of the digestive tract. Toxic if swallowed.Inhalation:May be harmful if inhaled. Causes respiratory tract irritation.
